Information document about the insurance product

Product: Easy4u computer insurance of The Rent Company

This Insurance Card only provides a summary of the insurance. The policy conditions state extensively what someone is and is not insured for.

What kind of insurance is this?

The Rent Company offers insurance cover for supplied tablets and laptops as part of the Easy4u subscription. This insurance is issued by MS Amlin and covers damage to your tablet or laptop supplied by The Rent Company.



What is insured?

✓ Damage, theft or loss due to a crime of the insured tablet or laptop. It concerns damage by others or by circumstances over which you have no influence, such as falls, impacts, induction and fire, theft or short circuit.

✓ Insured amount

The amount stated as such on the certificate.

Compensation

✓ In case of damage, the insurer will reimburse the repair costs. If repair is not possible (e.g. in case of theft) or if the repair costs exceed the current market value of the device, the insurer will reimburse the claimant for the cost of a replacement device that is comparable in terms of functionality, age, condition and type. This at the discretion of The Rent Company.

Extra information

Reimbursement will only be applicable if any repair or replacement is carried out by The Rent Company.

Reimbursement will be made directly between the insurer and The Rent Company.

The deductible will be settled with the insured by The Rent Company.



What is not insured?

✗ There is no coverage in the event of an earthquake, flood, acts of war, wear and tear or intent. Damage that is compensated under a manufacturer's warranty or service package is not insured.

✗ Digital information

Loss or corruption of software, data or any other form of electronically stored data.

✗ Maintain functionality

Damage that does not affect the functioning of the tablet or laptop, such as scratches, dirt or discoloration.



Are there any coverage restrictions?

! Deductible

A deductible per claim applies of € 50.

! Inadequate care

There is no coverage for damage or loss if you have not given sufficient care to the insured tablet or laptop.

! Theft from means of transport

Theft from means of transport is only covered in the event of traces of burglary on the means of transport. If you have not taken sufficient care to safely store the vehicle, there is no cover.

! Guarantee

Damage covered by the warranty will not be reimbursed under this insurance.

Extra information

Point of contact: Only repairs and replacement that you report to The Rent Company and that are handled by The Rent Company will be reimbursed.



Where am I covered?

✓ The insurance applies within the EU and the United Kingdom.



What are my obligations?

You must do as much as possible to prevent and limit damage. You must report damage directly to The Rent Company, but no later than within 14 days and provided with the necessary information to determine the cause of the damage and thereby determine the compensation payable.

Extra information

You should notify the police immediately if your tablet or laptop has been stolen or lost due to a crime and you must send the report directly to The Rent Company. You may only use The Rent Company for repairs to the tablet or laptop or a third party designated by The Rent Company, provided this arranged in advance.



When and how do I pay?

You pay this insurance when you purchase your Easy4u subscription. This can be done directly (electronically via iDeal) or afterwards via a bank transfer.



When does the coverage start and end?

The insurance starts on the date stated on the delivery note of the device. If you have not (yet) paid the purchase amount that includes the premium, we can cancel the insurance. The insurance ends automatically and legally on the end date of the Easy4u subscription that is linked to the device, but no later than 48 months after the start date.



How do I cancel my contract?

The contract cannot be cancelled early.
